

TRANSITIONAL COUNCIL REGULATION NUMBER 1

Pursuant to the authority vested in this Council by the Constitution of the Student Body,

The following is hereby promulgated:

Section 1 The Transitional Council

1. The Transitional Council (TC) shall temporarily exercise powers of government in order to provide for the effective administration of The Undergraduate Student Government (USG) during the period of transitional administration. Meetings of The TC shall be public, and records shall be open to public inspection. The TC shall be guided by Roberts Rules of Order when holding meetings and shall always retain the authority to develop its own procedures for operations within the bounds of the Constitution of The Student Body. The primary objectives of The TC shall be the adoption of the General Statutes of the Undergraduate Student Body, determining the composition of the 106th Undergraduate Senate, and ensuring a smooth transition to the new government.
2. The TC is vested with all executive and legislative authority necessary to achieve its objectives. This authority shall be exercised by The TC and those individuals empowered by The TC to act on behalf of The TC.
3. All members of The USG are instructed to support the operations of The TC.

Section 2 The Applicable Law

1. Unless suspended or replaced by The TC, laws in force as of November 6th, 2023, shall continue to apply insofar as the laws do not prevent The TC from exercising its rights and fulfilling its obligations or conflict with the present or any other Regulation or Order issued by The TC.

Section 3 Regulations and Orders issued by The Transitional Council

1. In carrying out the authority and responsibility vested in The TC, the TC will, as necessary, issue Regulations and Orders. Regulations shall be those instruments that define the institutions and authorities. Orders are binding instructions issued by The TC. Regulations and Orders will remain in force until repealed by The TC. Regulations and Orders issued by The TC shall take precedence over all other laws and publications to the extent such other laws and publications are inconsistent.
2. The promulgation of any Regulation or Order requires the approval of a majority vote of members present and voting. The Regulation or Order shall enter into force as specified therein and shall be disseminated as widely as possible.

**Section 4
Memoranda**

1. The TC may issue Memoranda in relation to the interpretation and application of any Regulation or Order.

**Section 5
Continuity of Governance**

1. All individuals who currently hold positions within The USG shall continue to hold their position until they are dismissed, resign, can not remain in their position, study abroad for one academic semester or longer, their term in office expires, or are otherwise removed from their position.
2. The 105th Undergraduate Senate shall continue to meet and transact business as the 105th Senate of the Undergraduate Student Body.
3. The Executive Board may continue to meet and transact business as the Undergraduate Executive Council. Individuals who previously held positions on the Executive Board whose positions are not on the Undergraduate Executive Council shall be allowed to serve on the Undergraduate Executive Council for the remainder of their term in office.
4. The following Officers shall continue to fulfill their duties as:

USG President	President of the Undergraduate Student Body
USG Vice President	Vice President of the Undergraduate Student Body
USG Treasurer	Treasurer of the Undergraduate Student Body
USG Secretary	Secretary of the Undergraduate Student Body
USG Chief of Staff	Chief of the Cabinet of the Undergraduate Student Body
The Speaker of the Undergraduate Senate	The Speaker of the Senate of the Undergraduate Student Body
The Speaker Pro Tempore of the Undergraduate Senate	The Speaker Pro Tempore of the Senate of the Undergraduate Student Body

**Section 6
Oversight and Reserved Powers**

1. All actions of The Senate of the Undergraduate Student Body, Officers of the Student Body, Undergraduate Executive Council, and any political subdivision or individual acting on behalf of those bodies shall be subject to the review of The TC.
2. Legislation that seeks to amend a statute that was in force prior to November 6th must be reviewed by The TC before it shall enter into force.

Section 7
Entry into Force

1. This Regulation shall enter into force upon adoption.
