TRANSITIONAL COUNCIL ORDER NUMBER 2

PROVIDING FOR THE CERTIFICATION OF GENERAL ELECTION RESULTS

Pursuant to the authority vested in this Council by the Constitution of the Student Body,

Recalling that the Constitution of the Student Body states in Chapter 1 Article V Section 8, "The representative bodies of the Constituencies shall be the sole judge of the elections, returns and qualifications of their members.",

Recalling further, that the Constitution of the Student Body states in Chapter 1 Article V Section 8, "They may vote to exclude a member-elect upon a two-thirds (2/3) vote if a member-elect does not meet the qualifications to hold office as prescribed by law. Complaints against such a decision may be filed with a court of competent jurisdiction.",

Recalling further, that the Constitution of the Student Body states in Chapter 1 Article XIII Section 2, "The provisions of any law or provision of this Constitution shall be considered severable and presumed Constitutional.",

Recalling further, that the Constitution of the Student Body states in Chapter 2 Article II Section 6, "The Senate shall be the sole judge of the elections, returns and qualifications of Senators.",

Recalling further, that the Constitution of the Student Body states in Chapter 2 Article II Section 6, "The Senate may vote to exclude a Senator-Elect upon a two-thirds (2/3) vote if a Senator-Elect does not meet the qualifications to hold office as prescribed by law. Complaints against such a decision may be filed with a court of competent jurisdiction."

Recalling further; that the Constitution of the Student Body states in Chapter 2 Article VIII Section 8, "The provisions of any law or provision of this Constitution concerning only undergraduate students shall be considered severable and presumed Constitutional.",

Noting, Title II Section 100 of The Code of the Permanent Laws of the Undergraduate Student Government of the University of North Carolina at Chapel Hill states that Senators shall, "Be elected in full compliance with the General Election Laws",

Bearing in Mind, the decisions of the 105th Senate of the Undergraduate Student Body taken at its meeting on 2/27/2024,
