## i. Informational Outline

William raised a concern about the separation of the Secretary from the Communications office. Treasurer Grodsky repeatedly spoke out of turn and without recognition by the Chair. The Chair was displeased. Gary moved to strike G.S. III:3110 and to create an appropriate section elsewhere designating the Secretary responsible for external communication of the Undergraduate Executive Branch. Williams seconded, Grodsky objected. Tweden moved the previous question without objection.

Gary moved the previous question on Regulation #8 by unanimous consent, Tweden seconded, Grodsky objected. Grodsky introduced the following amendment:

Section 2 Transition of Government

- A. The terms of the incumbent officers of the Undergraduate Student Body and of the 105th Undergraduate Senate shall end at 12:00:00 AM on April 2.
- B. The designate officers of the Undergraduate Student Body shall assume their powers at 12:00:00 AM on April 2 and shall assume their offices upon taking the oath of office.
- C. The 106<sup>th</sup> Undergraduate Senate shall assume its powers upon the calling to order of the first meeting of the 106<sup>th</sup> Senate and senators shall assume their offices upon taking the oath of office.

Amendment adopted without objection. Regulation adopted without objection.

Gary introduced the proposed Standing Rules of the 106th Undergraduate Senate.

Tweden moved to amend by:

- •Strike Rule 83
- •Strike from Rule 84(A): "and elected to another standing committee"
- •Amend Rule 85A:
  - To be renumbered to follow the preceding rule
  - O Amend "The Senate shall—by ballot—elect, from within," to read " The Senate shall designate from within:"
- •Insert two new rules following the current proposed Rule 85A to read as follows:
- Senate Organizing Resolution. Following the adjournment of the first regular
  meeting of the Senate, the Speaker shall originate and introduce an organizing
  resolution which designates the membership of all standing committees, all unfilled
  seats on permanent select committees and select or special committees, and all possible

Senate-designated external appointments, for consideration at the second regular meeting of the Senate.

- Committee Vacancies. Vacancies in posts filled by the Senate Organizing Resolution shall be filled on nomination by the Speaker.
- •Renumber rules accordingly

Gary seconded. Adopted without objection.

Gary moved the introduction and adoption of Order #4 and Memorandum #3. Grodsky seconded. Adopted without objection.

Tweden, on behalf of Baruch, moved the introduction and adoption of Regulation #7. Grodsky seconded, Shue objected on behalf of the Speaker Pro Tempore. Tweden moved the previous question, Forbes seconded.
